### **Main Bio**

Alope Chakravarty is the co-chair of Snell & Wilmer's investigations, government enforcement and white-collar protection practice group, and the firm's cybersecurity, data protection, and privacy practice. Al has handled several high-profile matters, including a nationally followed financial crime prosecution and a seminal prosecution of internet propagandists, and he also participated in the response and investigation of the Times Square attempted bombing. Al was a national leader in cross-government initiatives to develop community dialogue to protect civil liberties in the face of government national security enforcement activities. Through his government career, scholarly and teaching experience, and in private practice, Alope has also developed a niche in privacy law, in addition to his investigations and enforcement practice, and he is a certified information privacy professional in the United States (International Association of Privacy Professionals).
