### Main Bio

Jeff Martin's practice is concentrated around commercial finance. After graduating from law school, Jeff spent two years as an associate in the banking law group of a 250+ attorney firm before joining a client as its Director of Credit Administration and then the Division Counsel of its Asset-Based Lending and Factoring Group.
