AARON FORD SELECTED TO PARTICIPATE IN INTERNATIONAL EXCHANGE TO NEW ZEALAND

Political Study Program to Focus on Citizen Diplomacy

LAS VEGAS (September 14, 2009) — Aaron Ford, J.D., Ph.D., an associate with Snell & Wilmer L.L.P. in Las Vegas, has been selected by The American Council of Young Political Leaders (ACYPL) as a delegate to New Zealand for a 10-day political exchange program beginning on September 10, 2009. "I am honored to have been selected to participate in this ACYPL exchange to New Zealand," said Aaron Ford. "This will be an excellent opportunity for me to learn about the current political and social dynamics there and help the people of New Zealand better understand the United States."
