"Their appointments fulfill our goal of adding six, new dynamic community leaders to the board in 2010," says Jim Paluzzi, the General Manager for Public Radio stations KJZZ 91.5 FM and KBAQ 89.5 FM.

Phoenix is my home away from home so it's a natural fit for me to be of service to FPRAZ."
