Qualified lawyers are called to Fellowship in the College from all branches of trial practice. They are carefully selected from among those who represent plaintiffs or defendants in civil cases and those who prosecute or defend those accused of crimes. The College is thus able to speak with a balanced voice on important issues affecting the legal profession and the administration of justice.

Gibson's practice is concentrated in product liability, commercial, and environmental litigation. He represents manufacturers in product liability litigation involving motor vehicles, pharmaceuticals, aircraft, and machinery. He has tried numerous cases in his career for clients, including Ford Motor Company and Allergan.
