ORANGE COUNTY (August 5, 2011) – M.C. Sungaila and Todd Lundell, appellate attorneys in Snell & Wilmer’s Orange County office, will present at the *State v. Federal Appeals: Winning in Either Venue* seminar, hosted by Pincus Professional Education on Friday, September 9th at the Westin South Coast Plaza.

Over the past decade, she has been the architect of winning arguments to screen and exclude unfounded expert testimony in California courts—a standard which preciously remained undeveloped in the state. Sungaila has helped secure victories in many significant expert testimony cases decided by California appellate courts in recent years. Among numerous awards and recognitions, Sungaila was recently named one of California’s Top Women Litigators for the third time by the *Daily Journal*, one of the OC Metro Women To Watch in 2011, Visionary of the Year by Coastline Community College Foundation and Appellate Lawyer of The Week by the *National Law Journal*.

Lundell is a Certified Specialist in Appellate Law. He has worked on various civil appeals in the United States Court of Appeals for the Second, Eighth, and Ninth Circuits, and in state appellate courts in California, New York, Oregon and West Virginia. Lundell has prepared several certiorari petitions and merits briefs in the U.S. Supreme Court.
