Sungaila was named a Top Women Lawyer by the *Daily Journal* in 2011 and 2012, was listed on the *Best Lawyers in America*® Appellate Law list this year for the third consecutive year and is a 2012 *Super Lawyer*® in Appellate Law.

Sungaila is an active member of the Steering Committee of the ABA Women Rainmakers, a Vice-Chair of the Appellate Practice Committee of the International Association of Defense Counsel and recently was appointed to the Coastline Community College Foundation Board of Directors. As a contributing Editor of the ABA Section of Litigation's Woman Advocate Newsletter, Sungaila is focusing the Winter 2012 issue on mentoring and features advice from a variety of ABA women leaders.
