Panels discussed revolutionary legal, regulatory and ethical issues confronting both commercial and Native American gaming and shared valuable insights about the ever-changing field of gaming.

Staudenmaier, a partner in the firm's Phoenix office and nationally recognized in the areas of Indian Law, Gaming Law and Business Litigation, participated in the Gaming in Indian Country on After-Acquired Land; the Aftermath of the Carcieri Decision and an Update on Sovereign Immunity discussion. The panel focused on issues such as federally recognized tribes that continue to seek to develop casinos on after-acquired land, the dramatic reorganization the Bureau of Indian Affairs has undergone that has had a significant impact on the processing of petitions being filed by Indian tribes, and tribal casino operations that are being challenged based upon the Supreme Court's decision in the Carcieri case.

Dorsey, an associate in the firm's Las Vegas office, was involved in the Gaming Litigation Update panel which presented commentary on a variety of federal and state law issues affecting the commercial gaming industry's expansion into new markets and the internet, along with possible litigation concerns and strategy.
