## SNELL & WILMER ATTORNEY MICHAEL LIBURDI HONORED BY STATE BAR WITH PRESIDENTIAL AWARD FOR CONVENTION SEMINAR

**PHOENIX** (June 21, 2013) – Snell & Wilmer is pleased to announce that Michael Liburdi, an associate in the Phoenix office, was selected to receive the Presidential Award for his seminar, *Constitutional Policy and Legislation in the Era of Initiative*, at the State Bar of Arizona's Annual Convention.

Since this form of ballot measure serves as an alternative to the enactments of elected representatives, and sometimes as a direct check on legislatures, it has found increasing support across the political spectrum as a necessary component of the system of checks and balances. The interactive, case study-focused program, designed to encourage discussion on matters of public importance, gave attendees the opportunity to hear from a panel of authorities.
