## SNELL & WILMER'S AARON D. FORD NAMED ATTORNEY OF THE YEAR BY THE LAS VEGAS CHAPTER OF THE NATIONAL BAR ASSOCIATION FOUNDATION AND THE LAS VEGAS NATIONAL BAR ASSOCIATION

LAS VEGAS (Oct. 1, 2013) – Snell & Wilmer attorney Aaron D. Ford has been named Attorney of the Year by the Las Vegas Chapter of the National Bar Association Foundation (Foundation) and the Las Vegas National Bar Association (LVNBA). He will be recognized at LVNBA's 24<sup>th</sup> Annual Scholarship Gala on Saturday, Oct. 12 at the Culinary Academy of Las Vegas.

The Foundation is a public charity created to encourage diversity in the legal field by providing scholarships to minority and low-income law students. The LVNBA, founded in 1981, is Nevada's only affiliate chapter of the National Bar Association (NBA), which was founded in 1925 in Des Moines, Iowa at a time when there were fewer than 1,000 African-American lawyers in the nation. Today, the NBA is the nation's oldest and largest national network of predominately African-American attorneys and judges, with over 80 affiliate chapters representing 44,000 lawyers, judges, law professors and law students.

The mission of the LVNBA is to advance the science of jurisprudence and to improve the administration of justice. At last year's gala, the LVNBA gave eight law students a total of \$7,500 in scholarships.

"I am deeply honored to receive this award from two organizations that not only encourage diversity in the legal profession, but also generously support it through scholarships for low-income and minority law students," said Ford. "I personally want to recognize the Foundation and the LVNBA for the work they do on behalf of our students, several of whom are now practicing attorneys in Nevada."
