

ARMY JUDGE ADVOCATE GENERAL EXTENDS THE TENURE OF SNELL & WILMER ATTORNEY CRAIG DENNEY AS A MILITARY JUDGE IN THE FOURTH JUDICIAL CIRCUIT

RENO (January 22, 2014) – Snell & Wilmer is pleased to announce that The Judge Advocate General (TJAG) of the U.S. Army extended Nevada attorney <u>Craig Denney's</u> role as a trial judge in the Army Reserve for an additional three years. He will continue presiding as the trial judge for the Army's Fourth Judicial Circuit, which covers Army installations in Washington state, Colorado, California, Arizona, West Texas, Hawaii, Alaska, and South Korea, until June 2017.

As a military judge in the Army Reserve, Denney presides as the trial judge in General Courts-Martial and Special Courts-Martial (criminal trials) for active duty soldiers being prosecuted under the Uniform Code of Military Justice (UCMJ). He has served in this role since 2011.

In the Army Reserve, military judges typically serve for three years, however based on merit and the recommendations of the Chief Judge of the Army Trial Judiciary and the Commander of the 150th Legal Operations Detachment, the TJAG selected a handful of judges this year who were granted three-year extensions.

"I am deeply honored and appreciative of being selected by The Judge Advocate General to continue to serve as a military judge in the Army Reserve," said Denney. "It is a great privilege."

Denney graduated from the U.S. Army War College in 2012 and was promoted to Colonel in January 2013. Along with his esteemed career in the U.S. Army Reserve, Denney has also served as an Assistant United States Attorney in the District of Nevada, where he prosecuted complex federal offenses including money laundering, fraud schemes and federal regulatory offenses.

Denney has defended both corporate and individual clients in federal and state criminal and quasi-criminal investigations in Nevada and California.
