

## ABA PRESIDENT APPOINTS BARBARA DAWSON TO THE STANDING COMMITTEE ON THE FEDERAL JUDICIARY

**PHOENIX** (August 12, 2014) – Snell & Wilmer is pleased to announce that <u>Barbara Dawson</u>, a partner in the Phoenix office, has been appointed to the Standing Committee on the Federal Judiciary (FJC) of the American Bar Association (ABA).

The FJC evaluates the professional qualifications of all nominees to the Supreme Court of the United States, circuit courts of appeals, district courts (including territorial district courts) and the Court of International Trade. The Committee's goal is to support and encourage the selection of the best-qualified persons for the federal judiciary. It restricts its evaluation to issues bearing on professional qualifications and does not consider a nominee's philosophy or ideology. The Committee's peer-review process is structured to achieve impartial evaluations of the integrity, professional competence and judicial temperament of nominees for the federal judiciary. The FJC consists of 15 members – two members from the Ninth Circuit, one member from each of the other 12 federal judicial circuits and one member-atlarge. The members are appointed for staggered three-year terms by the President of the ABA.
