Dove](#) has been appointed to the Standing Committee on Judicial Ethics and Election Practices by the Board of Governors of the State Bar of Nevada. Her two-year term will begin in January 2015.

[The Standing Committee on Judicial Ethics and Election Practices](#) comprises six judges appointed by the Nevada Supreme Court, three of whom must be limited jurisdiction judges and three must be district court judges; 12 attorneys appointed by the State Bar of Nevada, one of whom is the chairman and one of whom is the vice-chairman; and 12 non-attorneys (lay members) appointed by the Governor.

“I am honored to have been selected for this committee,” said Dove. “I look forward to working with this esteemed group on judicial and ethical matters important to our state and contributing to the bar and our community.”

The Standing Committee was created to provide judges and aspirants to judicial office advisory opinions regarding ethical matters that may arise in the ordinary course of judicial service, or in the elective or appointment process. Each member is appointed for a two-year term, with no member appointed to more than four consecutive terms. The Standing Committee also assists the Supreme Court by studying and recommending additions to, amendments to, or repeal of provisions of the Nevada Code of Judicial Conduct or other laws governing the conduct of judges and judicial candidates.

Dove earned her B.A. from Randolph-Macon Woman’s College; her M.A. from Rice University and her J.D. the University of Nevada, Las Vegas, William S.
