### NEVADA OFFICES OF SNELL & WILMER RECOGNIZED WITH PACESETTER AND LIVE UNITED 20 AWARDS FROM THE UNITED WAY OF SOUTHERN NEVADA

**LAS VEGAS (November 11, 2015)** – Snell & Wilmer is pleased to announce that the Las Vegas and Reno offices were the recipients of two awards from the United Way of Southern Nevada at the close of the firm's 2015-2016 campaign on October 26. Campaign co-chair and Snell & Wilmer attorney Justin Shiroff accepted the awards on behalf of the firm, whose employees donated a total of \$11,244 with a record 67 percent employee participation rate.

The first award was the Campaign Pacesetter Award, which recognizes companies that have “set the pace” for raising the first \$1 million for the 2015-2016 campaign. Snell & Wilmer was one of 17 community champions that received this recognition.

The second award was the Live United 20 Award for the firm's 2014-2015 campaign, which is given to the top 20 companies with the highest employee participation rate.

“We are honored to receive these awards and to be recognized as a Pacesetter for the second year in a row,” said Taylor Anello, campaign co-chair and Snell & Wilmer attorney. “The firm has been a longtime supporter of the United Way and looks forward to continuing our commitment to help our Southern Nevada community.”

This year marks Snell & Wilmer's Third Annual Campaign in the Nevada offices. During the past three years, Snell & Wilmer attorneys and staff have contributed a total of \$34,949 to the United Way.

In addition to receiving the Campaign Pacesetter and the Live United 20 awards, the Nevada offices have also received other awards for community involvement, including the 2014 Philanthropic Business of the Year Award by Vegas Inc. and the Lied Award by the Legal Aid Center, which is given to a law firm contributing the most pro bono hours in a given year.
