Upon appeal of a dismissal of the challenge in the United State District Court, in October 2014, the Ninth Circuit Court of Appeal ultimately reversed and remanded the lower court's dismissal of the case, declaring the state marriage ban unconstitutional and ordering entry of a permanent injunction to protect marriage equality in the State of Nevada.

Dove earned her B.A. from Randolph-Macon Woman's College; her M.A. from Rice University and her J.D. the University of Nevada, Las Vegas, William S. Boyd School of Law, where she ranked first in her class. In 2015, she was the recipient of the William S. Boyd School of Law Distinguished Service Alumni Award. She has been named to the Honor Roll, the 50 Hours Club and the 100 Hours Club by the Legal Aid Center of Southern Nevada for her pro bono service. Prior to joining Snell & Wilmer, Dove was a judicial clerk to both Hon. Philip M. Pro in the U.S. District Court, District of Nevada and Hon. Jay S. Bybee of the U.S. Court of Appeals, Ninth Circuit.
