CHAMBERS ASSOCIATE GUIDE ONCE AGAIN RANKS SNELL & WILMER AMONG TOP 10 FIRMS IN THE UNITED STATES

PHOENIX (July 29, 2016) – Snell & Wilmer is pleased to announce that the <u>Chambers Associate Guide</u> ranked the firm seventh out of approximately 130 law firms whose associates were interviewed for "The Happiest Law Firms 2016" survey. This is the second consecutive year the firm ranked in the top 10. In addition, Snell & Wilmer is the only firm in the top 10 with a presence in Phoenix.

Unlike some surveys, which simply tabulate previously completed online surveys, Chambers interviews associates from across the country, including associates in multiple offices of the larger firms. The Chambers researchers gathered this primary data by speaking to Snell & Wilmer associates and asking them for a happiness and stress rating out of 10 – and then compared that with how happy they expected to be. In the <u>recently released rankings</u>, one associate stated, "they don't put associates through a hazing process here. Everybody is here to help and rooting for you . . . Nobody here is trying to break you or pull the rug out from underneath you." Another associate emphasized that "people really come and make Snell their home. Everyone gives you the tools to succeed. I'm in it for the long haul."

Snell & Wilmer chairman <u>Matthew Feeney</u> said, "These results reflect the commitment of our partnership to developing our associates into self-sustaining partners. I want to particularly recognize the efforts of our Attorney Development Committee, under the leadership of partner Bahar Schippel, which does a great job keeping us focused on the issues that matter to our associates."
