According to the Business Journal, the largest private companies in Arizona generate revenues of over \$15 billion per year and employ over 40,000 employees in the State of Arizona and over 56,000 worldwide, making these companies very important to the economy of Arizona and the families they employ. The awards are based on a score that ranks growth, revenue, innovation and community impact. To be eligible for the awards, a company must be independent (no parent company), be privately held (not publicly traded), have revenue of at least \$7 million in each of the two most recent fiscal years, and be headquartered in Arizona. Verification of company revenue is conducted by accounting firm CliftonLarsonAllen.
