Program designed for first-generation and diverse students interested in law school

LAS VEGAS (April 25, 2019) – Snell & Wilmer is pleased to announce its early support of The Justice Michael L. Douglas Prelaw Fellowship Program, newly created for first-generation and diverse college and high school students to explore and potentially pursue a career in the law. Established by the UNLV William S. Boyd School of Law and named after the first African-American Supreme Court Justice in Nevada's history, the program will officially launch in April. Snell & Wilmer is one of Nevada's first law firms to endow a fellowship for the program and John S. Delikanakis, a partner in the firm's Las Vegas office will serve on the program's advisory board.

The Justice Douglas PreLaw Fellowship Program will offer undergraduate students simulated law school classes and LSAT preparation. PreLaw recipients will gain insight on best practices for applying and succeeding in law school. The program will also provide information and resources on the application process and the information students need to be prepared for law school. The program will take place at the UNLV William S. Boyd School of Law in Las Vegas.

"Justice Douglas is a trailblazer within the legal community and a great advocate for underserved communities across Nevada," said Delikanakis. The Honorable Michael L. Douglas was appointed to the Court in March 2004, and thereafter elected three times. He served as Chief Justice in 2011 and 2018. His Nevada career began as an attorney with Nevada Legal Services in 1982. Two years later, he was hired by the Clark County District Attorney's Offices and served in the Civil Division until 1995. In 1996, he was appointed to the Eighth Judicial District Court bench. He took office and was retained in an election later that year, serving until his appointment to the Supreme Court.
