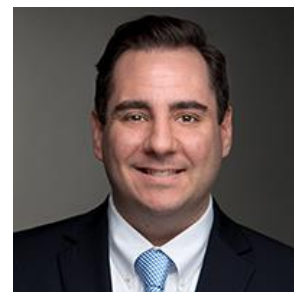

Philanthropy award created in honor of former Snell & Wilmer chair John J. Bouma

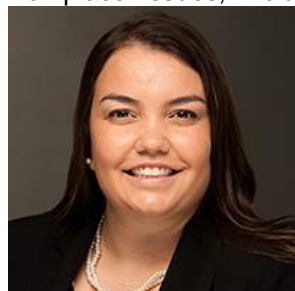
