PHOENIX (September 4, 2020) – Snell & Wilmer mourns the loss of Donald L. Gaffney (68), who passed away on September 3, 2020 after battling cancer.

Gaffney, who joined the firm in 1989, was senior partner in bankruptcy, reorganization and workout law. He had significant experience in privacy law, electronic payments and commercial litigation.

In addition to being one of the most highly regarded practitioners in his field, throughout his career he has quietly and effectively taken on numerous important pro bono engagements, including assisting Brophy College Preparatory in a complicated acquisition of an aquatic center through a bankruptcy proceeding.
