Staudenmaier is nationally recognized in the areas of Native American Law, Gaming Law, and Business Litigation. She represents tribe, tribal entities and businesses who engage in commercial transactions with tribes and tribal entities. She was the 2019 recipient of the American Bar Association Business Law Section's prestigious Jean Allard Glass Cutter Award, which is presented annually to a woman who has cut through barriers to attain high accomplishment in business law, and she is the only Arizona attorney to ever receive this high honor. Also in 2019, Staudenmaier was inducted into the Maricopa County Bar Association Hall of Fame; named to the inaugural class of Arizona Capitol Times' Women Achievers of Arizona; honored as a Finalist for the Greater Phoenix Chamber of Commerce's ATHENA Awards; and recipient of the University of Iowa College of Law's 2019 Alumni Service Award.
