Throughout the year, Snell & Wilmer has engaged in over 300 pro bono matters, contributing to over 25,000 hours worked, that directly affect minority individuals and communities and provided over two dozen initiatives and CLE's that offered diversity-focused professional development and/ or a better understanding of diversity in the legal profession.

Snell & Wilmer attorneys across our offices are pleased to contribute their time and talents to being actively involved in a variety of legal industry, charitable, civic, and professional boards. Attorneys and staff from the firm's Orange County office recently participated in the following community-focused programs, as well as others:

- **Adopt a Troop** – In November 2021, the firm's offices, including Orange County, joined to support over 100 Marines in the Marine Corps Embassy Security Group Region 6 Eastern and Southern Africa through the donation of created care packages including wish list items sent directly to deployed individuals.
- **Project Youth – Orange County Bar Foundation – OC Marathon Fundraising Event** – In November 2021, members of the office participated in the OC Half Marathon, virtual Half Marathon and 5K. Snell & Wilmer's team raised donations in support of Project Youth OCBF.
- **American Cancer Society – Making Strides Against Breast Cancer Orange County** – In October 2021, the Orange County office's team "Beyond Rubies" raised over \$4,000 while participating in a three-mile walk route to support the cause. This annual fundraiser raises money to support services and lifesaving research to end breast cancer.
- **Second Harvest Food Bank of Orange County – Food from the Bar campaign** – In October 2021, the office participated in this month-long annual campaign which is a friendly competition within the Orange County legal community that helps raise awareness and provide critically needed meals to food-insecure children, families and seniors in the community. The campaign provides critically needed food to vulnerable people in Orange County, including those who have been affected in unprecedented ways due to COVID-19. Including matching contributions pledged by firm's leadership, the office surpassed its goal of \$2,500, raising \$2,695 in donations, which is equivalent to over 8,000 meals.
- **Orange County United Way – Annual Fundraising Campaign** – In September 2021, the office focused on its continued commitment to the Orange County United Way through the Snell & Wilmer 2021 United Way Fundraising Campaign. This annual week-long event had participants across the Orange County office competing in a variety of activities to raise money for the community. This year's campaign included a homemade dip contest, silent auction, group workout and the Snellympics, culminating with the championship match of the weeklong ping-pong tournament.
